Staff drafted a letter to the Heritage Preservation Commission (HPC) in regard to their suggested policies for The Commons and the Blue Line Ticket Booth. Staff worked with Chair Tom Wolfe and Commissioner Dave Wahlstedt on the draft letter that would be provided in response to the proposed review policies submitted by the HPC.

Following the feedback from Chair Wolfe and Commission Wahlstedt, the letter attached to this memo is the draft provided for review by the Park and Recreation Commission.

Commissioner Wahlstedt also provided the comments below in regard to the Blue Line Ticket Booth Review Policy:

"Regarding the Heritage Preservation Commission's proposed "Port of Excelsior Blue Line Ticket Booth Review", the Parks and Recreation Commission is supportive of Heritage Preservation Commission review of changes to the structure of the ticket booth, but, as it has historically, we believe the content of the displays should reflect whatever is currently relevant to the city. This will certainly include the types of things mentioned in the HPC proposal, but may also include other things like a "wayfinding" poster of the City and a City sponsored event schedule poster. Decisions of what to display could be made by the Parks and Recreation Commission, or by a combined team that includes members of the Heritage Preservation Commission as well as city staff and perhaps the Chamber of Commerce."

The Commission should determine whether the attached draft response is the version they would like to provide to the HPC or if further revisions are necessary. The Commission should also determine if they would like to use the language noted above by Commissioner Wahlstedt in regard to the Blue Line Ticket Booth Policy.

The Parks and Recreation Commission has conducted the review of the proposed Heritage Preservation Committee policies for both The Commons and the Blue Line Ticket Booth as well as the Community for The Commons (C4C) Capital Improvement Process Policy proposal. After discussing the policies for two meetings, the Parks and Recreation Commission has drafted comments for the review of the Heritage Preservation Commission (HPC).

The Parks and Recreation Commission feels as though the Master Park Plan process was very thoroughly conducted. The Master Plan engaged the community, the Commissions, and the City Council and provided for very detailed feedback regarding proposed changes in The Commons. Throughout the process, several stakeholders from the Parks and Recreation Commission, Heritage Preservation Commission, and the City Council were engaged and provided important feedback for all facets of the plan. Ultimately, the Master Park Plan was supported unanimously by the Parks and Recreation Commission, Heritage Preservation Commission, and the City Council in the Fall of 2017.

Because the Master Park Plan process was so successful and well received, the Parks and Recreation Commission agreed that it would make sense to follow a similar path forward in executing the Master Plan. A design committee (similar in membership to the Master Plan Committee) should be appointed by the City Council for each capital project. A committee could also be appointed to define the standards for "non-capital" amenities in the park such as park furniture, signage, lighting fixtures, etc. A public engagement element should be included in all design processes. Parks and Recreation Commission supports the notion that this public engagement process will be integral to making upgrades and improvements within The Commons.

Furthermore, in November of 2017, Preservation Design Works (PVN) conducted a Site Inventory and Period of Significance Study for The Commons and The Port of Excelsior. Extensive research was conducted by PVN to determine the historical significance of several features within the park including buildings, view corridors, park equipment, and other park amenities. Ultimately, the period of significance for The Commons was determined to be from 1854-1937 and for The Port from the 1870s-1955.

PVN used the research and the historical designation criteria provided in the report to determine what was deemed historically significant and what is not. Using the criteria within the report, the equipment, park furniture, band shell, buildings, signage, and other features were deemed not historically significant or character defining to The Commons. The ballfield seating, location of the ballfield and the beaches, vegetation, great lawn, and overall topography of areas within the park were determined to be character defining features with historical significance.

The Parks and Recreation Commission feels as though the PVN report confirms the lack of historical significance of features within the park including playground equipment, furnishings, structures, and other amenities. The PVN report provides a third party, unbiased review of the historical elements and features within The Commons and The Port of Excelsior. This review further supports the notion that many of the features are not historically significant or character defining using the PVN's criteria within the report.

The Parks and Recreation Commission agreed that the PVN study adequately defines the historically significant features in The Commons. Heritage Preservation Commission review should be limited only to any proposed modifications to these features. There exists no historical perspective with which to review any new projects. Beyond this, The Commons should be a "clean slate" with the opportunity to create our own historical character. Parks are ever evolving and changing, and the Parks and Recreation Commission feels as if the Master Park Plan provides the opportunity to create a new, vibrant history moving forward with the communities' desires at the forefront.

The Parks and Recreation Commission is generally supportive of the Heritage Preservation Commission's proposed "Port of Excelsior Blue Line Ticket Booth Review". However, the Parks and Recreation Commission did feel that a "wayfinding" poster of the City and a City sponsored event schedule poster would be appropriate content for the booth.

Finally, the Parks and Recreation Commission is supportive of the proposed "Commons Park Capital Improvement Process" as written by C4C. It was agreed that the C4C document would make an excellent policy to guide the execution of the Commons Master Plan.

MEMORANDUM

Re: Item 6(a) - First Street Cottages

BACKGROUND

The property owner of 125 First Street is willing to donate one of the cottages at their property for the City to relocate. The Council asked that the Park and Recreation Commission discuss if and where they would like these cottages.

DETAILS/ANALYSIS

Deadline. The builders of the future new home on 125 First Street have reached out to the owners of this property, and the owners have indicated that they would be willing to donate a cottage provided the City will cover the cost of moving it. Staff has reached out to the owners to see the date by which the cottage needs to be removed and has not heard back.

Location. The Council had discussed moving the cottage(s) to Excelsior-Studer Park, where there is a concrete pad that currently serves as a pad for a picnic table. Staff measured this pad, and it measures 20 feet by 20 feet. Alternatively, there was discussion if there was a location within the Commons that would be appropriate.

Inspection of Cottages. Neither staff nor any members of the Council have had the opportunity to inspect the inside of the cottages at 125 First Street, as staff has not yet heard back from the owners.

Approximate Cost. The moving company estimated that the move would likely cost between \$9,000 to \$11,000, and this does not include overhead wire work. Additionally, the eaves may limit the location to where the cottage(s) can be moved. Also not included in this cost is the cost of the foundation. The builder expressed that a reinforced slab with a thickened edge would be appropriate, and the cost of this would be from \$5,000 to \$10,000.

ACTION REQUESTED

The Park and Recreation Commission should discuss if and where they would like to see these cottages relocated.
