A Letter From The Mayor

Welcome to spring! Our residential dock expansion is nearing completion and is a great example of how the City is using its resources effectively to financially offset the need to improve our city's aging infrastructure. A less visible example of how the City is working for you is completing the City's ten-year Comprehensive Plan for 2018. In late January, the City hosted an open house to gain insight from residents and commercial property owners for our Comprehensive Plan. The open house was well attended, and we received over 40 comment cards with detailed information on where the City should focus their efforts over the next decade.

The open house presentation and comment cards are available on the City's website, but I thought it would be helpful to address a few of the recurring themes in the comments. Over the past five years, our city has seen 25 residential teardowns and rebuilds and there is great concern from some of our residents for protecting the integrity of our housing stock. The City Council has enacted a moratorium for residential teardowns and rebuilds with the intent of making changes to our residential zoning to limit height, increase side yard setbacks, and reduce overall building mass before the moratorium expires in May. We have also established a committee of residents to study long-term solutions like a conservation district for the residential neighborhoods.

Another comment card theme was high taxation shouldered by our residents. Our effective tax rate is 27% of adjusted net tax capacity and is ranked 4th lowest out of the five cities in the South Lake Region, and 13th lowest out of the 45 cities in Hennepin County. The City Council is very concerned about keeping our tax levy consistently low and keeping our government efficient. While 20% of your property taxes stay in the city, approximately 39% goes to the school district, 34% to Hennepin County and the remaining 7% to special taxing districts (such as Metro Transit, Met Council, and the Watershed District).

It's also important for the City to keep our downtown business district vital as approximately 32% of our tax levy is paid by commercial property owners. In recent years, we have added more businesses by thoughtful deliberation and City Council actions. A great example is the redevelopment of a car dealership into Kowalski's . We need to continue to apply our disciplined approach to growth on the East Side with our recently adopted long range vision effort. (Continued on back page)

PLEASE NOTE: CITY HALL WILL NOT BE OPEN ON FRIDAY, MAY 11TH FOR PURCHASING VOUCHERS. PLEASE PLAN ACCORDINGLY.

Items NOT Accepted:

Motor oil, paint, cement, railroad ties, and hazardous materials.

Items Picked Up Curbside Without a Coupon:

- ♦ Household trash, small pieces of furniture, grills, toilets and sinks.
- Weeds, leaves, and lawn clippings (bagged in compostable bag and placed separate from other items)
- Brush and limbs MUST be bundled in lengths of 4 feet or less

New Construction Hours

Construction hours for private property are between 7:30 am and 7:00 pm on weekdays, and 9:00 am and 6:00 pm on Saturdays. Construction is prohibited on Sundays and federal holidays.

What Needs a Building Permit?

A building permit is required any time you do work that is regulated by the Building Code. This includes work, such as siding, windows (if altered), roof, additions, garages, and decks. Work that is exempt from a permit includes: painting, wallpapering, flooring, kitchen cabinets, minor repairs and detached storage buildings not exceeding 120 square feet. Tree Contractors and Refuse Haulers Require a License

City ordinance requires that any tree contractor or refuse hauler performing work in Excelsior retain and have a current license in their possession. The license requires that all contractors adhere to Excelsior's ordinances and perform to the City's expectations.

Prevent Stormwater Pollution Report Illicit Discharges

As a community member, you play a large part in detecting illicit discharges in our City. An "illicit discharge" is the illegal act of disposing, dumping, spilling, or other discharge of any substance other than rainwater into the streets, gutters, ditches, and ponds that make up our stormwater drainage system, or directly into streams or lakes themselves. What can you do about illicit discharges? If you see anyone releasing any material other than rainwater into the street or storm drains, please report it to Public Works at (952)474-3464. For potentially hazardous materials, call 9-1-1 FIRST when there is an immediate threat to life or property.

Parking Permits & Restrictions

Each household is allowed to purchase parking stickers for vehicles registered to the household address. A parking permit allows residents to park at the meters in Excelsior without having to pay the meter. Each parking sticker is \$10.00. Permits may be purchased at City Hall during regular office hours and you MUST bring the registration (annual renewal for your license tabs) for each vehicle. No vehicle shall be parked continuously at any public place for a period of more than 48 consecutive hours.

Residents of the City may park on public streets within the City for unlimited time periods if their vehicle displays the annual City parking sticker.

A Letter From The Mayor (Continued from Front Page)

It's important that the City commits to selling the 810 Excelsior Boulevard property (former Police building) with a proposal that is best for the overall vitality and continuity of the City. We are hopeful that the 810 site will take hold and act as a catalyst for redevelopment of the former BayView parking lots, Bayside Grille, and its lakeshore. It's important for the City to influence redevelopment of the lakeshore as it's a vehicle for economic growth and public access.

As we update the Comprehensive Plan, we must embrace a holistic view of the City from a visual and financial perspective. While the City is in great shape financially, the ongoing need to improve our roads, utilities, and parks will ultimately outpace the City's revenue in the future. The local sales tax referendum voters approved in 2014 has not been successful in the state legislation, primarily due to our local State House Representative unwilling to support our voters. Without the local sales tax, the City has few financial options in paying for improvements: raise the tax levy, allow controlled growth to increase tax capacity, utilize our assets to create more revenue, or keep the status quo and do minimal improvements. We would be doing a disservice to our residents if we substantially raised the tax levy or do nothing, and we are already utilizing our assets, as I mentioned earlier with the dock expansion, so that leaves us with embracing controlled growth of our business and residences. We need to remain open to new proposals brought forward by commercial and residential developers and balance the need to retain our historic charm.

Please join us at our City Council meetings or talk with a City Council member to help us make Excelsior a great place to live, work, and play.
