**Re:** City Hall Options

At the March 21<sup>st</sup> work session, the Council continued to review potential sites for city hall and narrowed it down to the following options:

Address	Option	Cost Estimate
339 Third Street	Remodel the former Excelsior Library space	\$750,000 - \$1M*
339 Third Street	Construct a new building	\$1.4M - \$2.0M**
261 School Avenue	Relocate to the former Excelsior Public School building	\$4.0M

\* Cost estimate does not include securing the existing building foundations, additional investigative work would need to be done to obtain a more refined cost estimate.

\*\* Cost estimate is preliminary and based on concepts versus actual design.

This work session will focus on the following questions:

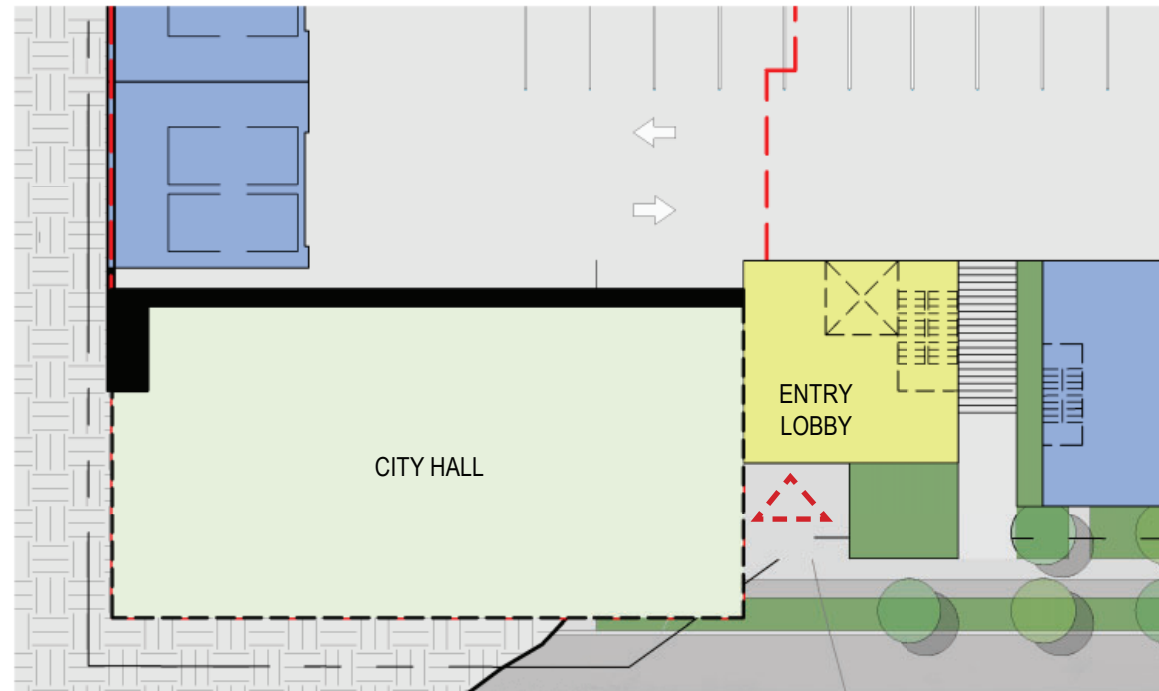
- Are there any options that the Council is no longer interested in as a potential city hall site?
- How does the Council want to address the topic of city hall at the open house?
- Is there additional information that the Council needs to decide on a city hall location?

Included in the packet are the following supporting materials for each option:

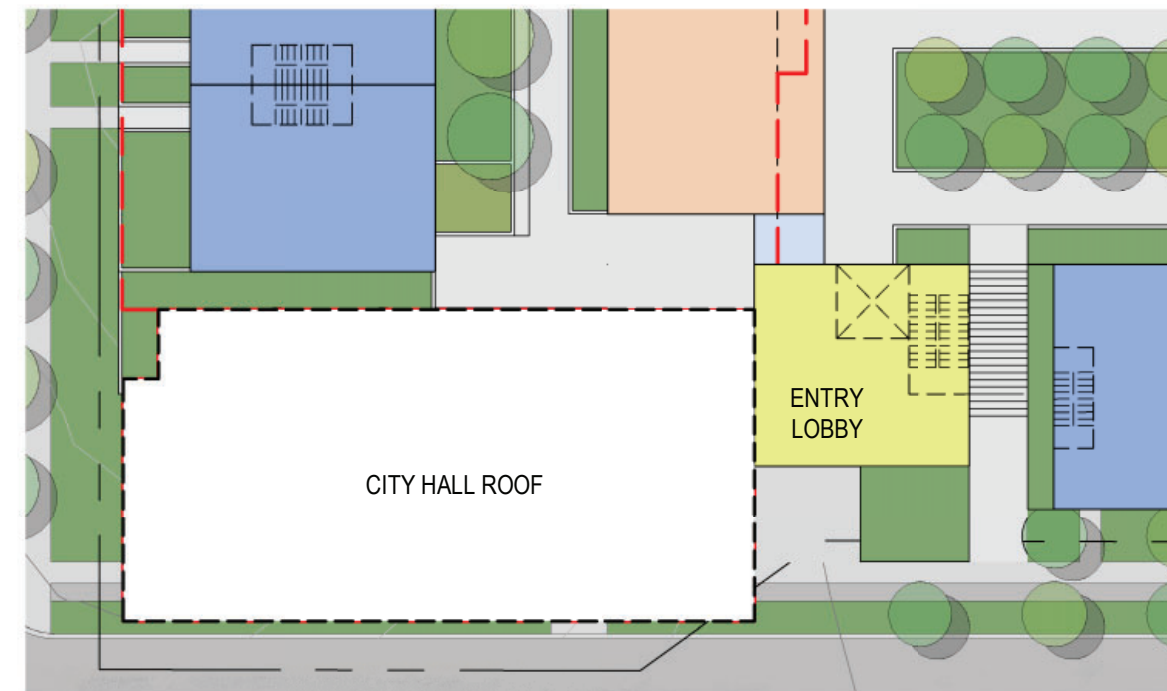
- 339 Third Street Remodel – Partial plans for remodeling the former library space, along with some factors to take into account when considering this option
- 339 Third Street New – Partial plans showing options for constructing a new building
- 261 School Avenue – A detailed financial analysis is included in the closed session packet

With Red Leaf Partners preparing to submit a sketch plan application in late May or June, a decision regarding whether city hall is incorporated into the redevelopment plans for 339 Third Street should be made no later than the May 2<sup>nd</sup> meeting.

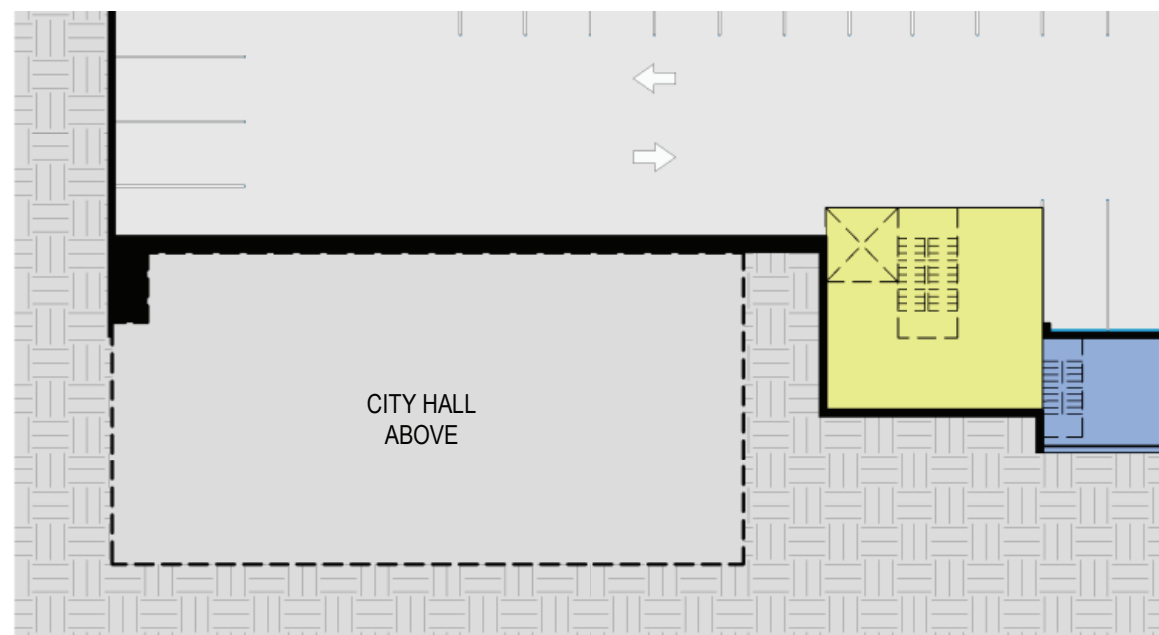
# CITY HALL OPTION PARTIAL PLANS (FORMER LIBRARY)

MAIN LEVEL (LEVEL 01)

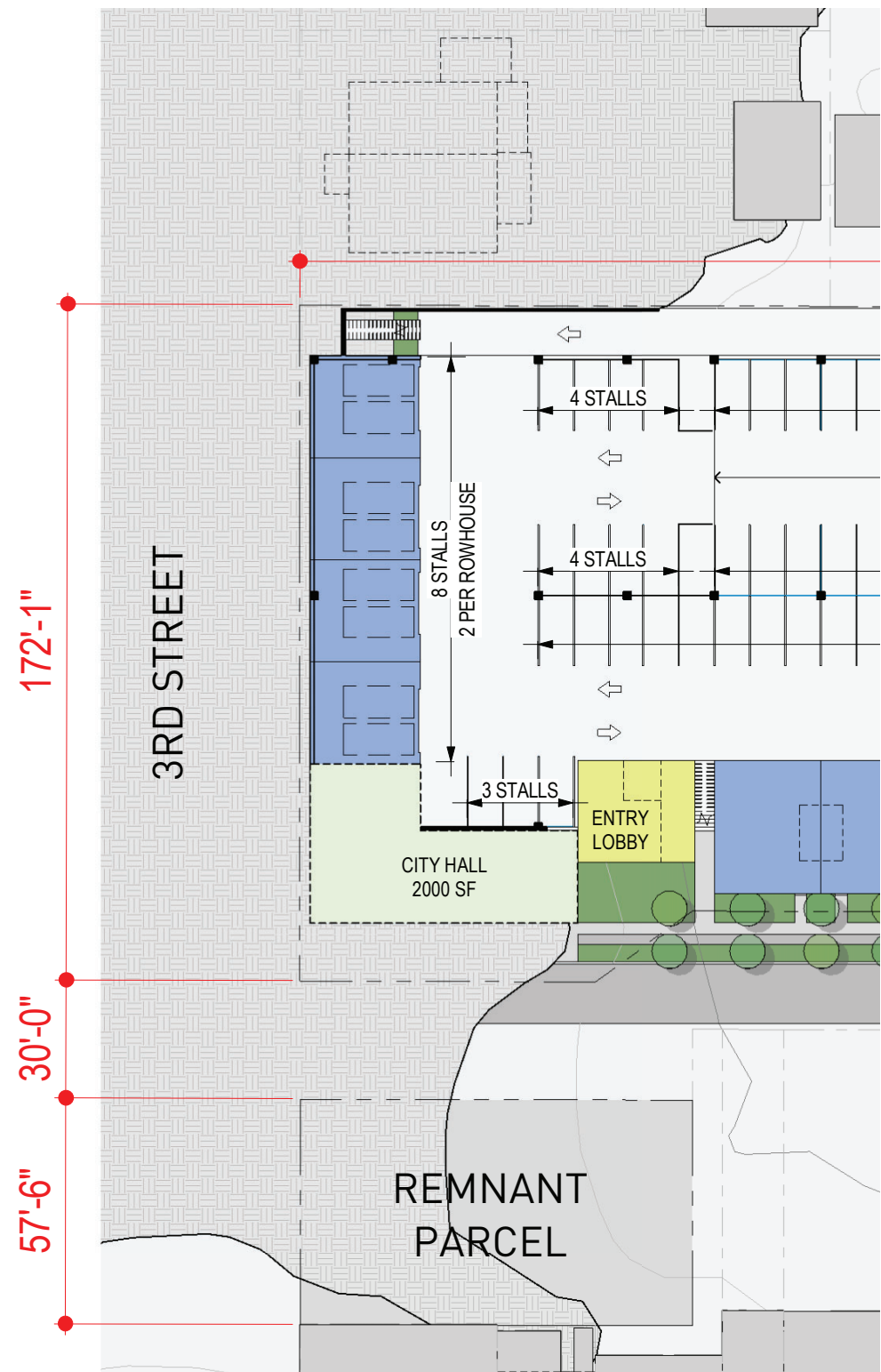


PARKING LEVEL TWO (BELOW GRADE)

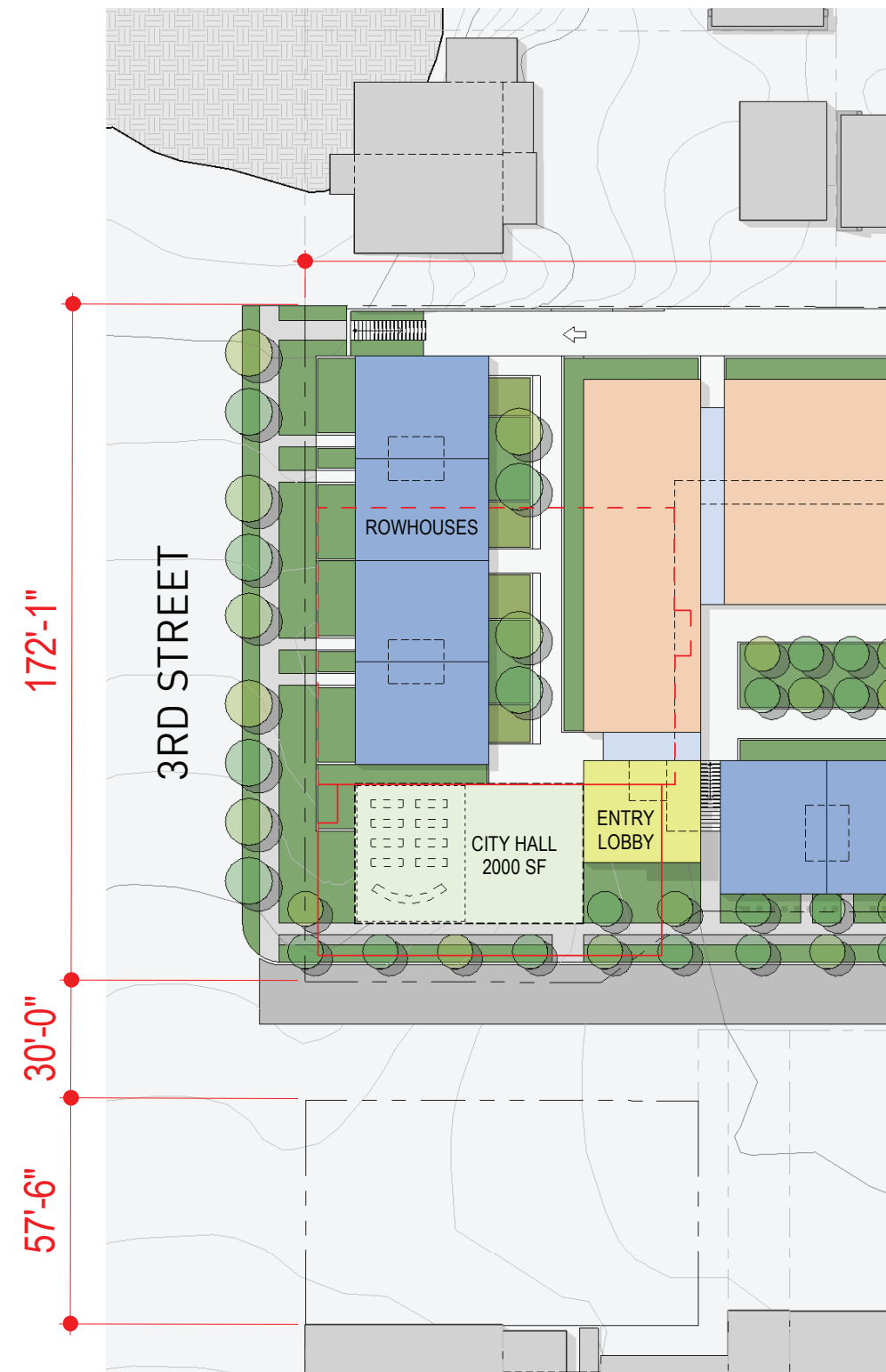
## OPTION CONSIDERATIONS:

3. UNKNOWN COSTS IN SECURING EXISTING BUILDING FOUNDATIONS
4. UNKNOWN COSTS IN ACCESSING EXISTING BUILDING UTILITIES
5. ADDITIONAL SPACE REQUIRED FOR BUILDING MECHANICAL SERVICES
6. AESTHETIC IMPACTS TO THE PROPOSED ADJACENT DEVELOPMENT
